1 [PROCEEDINGS ON 2 AUGUST 2017]

2 CHAIRPERSON: Is that on? Good evening,
3 Ingwelala members. Welcome out on this relatively cold
4 night. Thank you for your attendance here tonight at this
5 general meeting. Registration as per normal please. Proxy
6 collection as per normal. I'm just waiting for the
7 registration table to count up the number of people and
8 votes that are here and as soon as I get I'll let you know
9 how many of Ingwelala's 1 500 shares are here and
10 Buffelsbed's 209, OP Goedehoop's 200 and Sibon's 196. But
11 I think it's fair to say, you know, pending that
12 information that we have more than enough to form a quorum.

13 So if I could just outline the proceedings here
14 tonight after my brief introduction here I'd like to go
15 through, you know, the structure of the meeting. I would
16 like to point out that at the request of a member this is a
17 normally minuted meeting but at the request of a member the
18 meeting will be audio recorded as well on a machine over
19 here which means that we placed this mic over here, that if
20 you are going to be talking please will you go to the mic,
21 identify yourself and your bungalow number.

22 Please do it clearly because the, it's quite
23 possible that the audio recording may well be transcribed
24 one day. So please talk clearly into the mic and state
25 your name and bungalow number. So the purpose of the

1 meeting is the four resolutions, the four unrelated
2 resolutions we've described. There are a couple of seats
3 in front. I know it's like church. There are a few over
4 there as well. So the ground rules are the speakers over
5 here could you please be concise in your questions and
6 precise in your comments. It's quite a crowd. As I say we
7 will have a quorum number at the moment.

8 We have given combined notice of the meetings
9 because all four resolutions are identical and all four
10 considerations are identical and so we have precedent for
11 that. The meeting at the AGM last year was combined notice
12 so we intend to run it on that basis. I will in a moment
13 deal with the original notice of meeting. When we get to
14 voting we will seek a proposer, a seconder for each of the
15 resolutions and we'll have some debate and at some point I
16 guess we will have to vote on those.

17 We'll do that through all four. And then after
18 that we'll appoint some scrutineers to count the votes and
19 while they're counting the votes we can have a bit of a
20 break and they can come back and tell us the number. We'll
21 deal with the agenda item number 5, any other business, and
22 then we'll declare the meeting closed. So I'm just waiting
23 for the numbers and that but in the interim, so the
24 original notice that was sent out has been reported
25 allegedly to be defective in that the names of the three

1 directors of the three subsidiary companies or the three
2 minor companies were not displayed on the notice. A
3 correction thereof has been suggested in the last number of
4 days in terms of the memorandums of incorporations of the
5 companies. This I regard as the chairman in terms of the
6 memoranda of incorporations, I regard as a non-fatal, as
7 immaterial or not material to the notice of those meetings
8 and therefore regard that as immaterial. Mr Vos.

9 MR DE VOS: Hello. Thank you, Mr
10 Chairman and members of Ingwelala.

11 CHAIRPERSON: Mr Vos, this is a recorded
12 meeting. Could you identify yourself and your bungalow
13 number please?

14 MR DE VOS: Thank you. I am Christo de
15 Vos, bungalow 87. And I present quite a number of meetings
16 who gave me their proxies to talk tonight. So it however
17 saddens me to bring up this point that the meeting was not
18 properly constituted tonight. It's not properly called.
19 We received a defective notice and when that was brought
20 under the attention of the board they now rectified the
21 notice by sending out another notice.

22 So the new notice if that is now the correct
23 notice also contains changes in the wording of the
24 resolutions. It's not the same resolutions that was
25 exactly the same wording as the previous notice. So we sit

1 with two notices, the one by acknowledgement of the board
2 is wrong, materially defective, otherwise they wouldn't
3 have sent out another notice. The second notice now has
4 another problem because we haven't got 15 days' notice to
5 consider the proposals in that meeting. So by sending out
6 the next notice, Mr Chairman, you actually painted yourself
7 in a corner.

8 This meeting cannot proceed for that reason alone
9 but I've got other reasons as well. That's the first
10 reason. So you can't on the one hand say, okay, I'm
11 rectifying it but not give us enough notice. You know,
12 that's also not fair because this notice was not given a
13 long time ago, not even ten days ago. It was given two
14 days ago. I was travelling the last two days to get here
15 in time. I travelled from Stilbaai by motor car. How must
16 I on earth do you think must I contact the guys who gave me
17 proxies and discuss these amendments and discuss what we're
18 going to do?

19 So it is just unfair. In the sake of fairness we
20 can't go on and then it's materially defective on the one
21 side and the other side if we accept the second notice we
22 haven't got enough days as prescribed in the Act and that
23 we must have. So we have a problem that the meeting cannot
24 go on, on the basis of that. Then resolutions 2, 3 and 4,
25 I've got a big problem with them because we cannot even

1 vote on those proposals even if we go on with the meeting
2 because it's not allowed in terms of our constitution. Our
3 constitutions and the Share Blocks Control Act do not
4 provide for any activities outside that of running the
5 share block. That means we cannot, we cannot engage
6 ourselves in any other activities. We cannot receive
7 donations to get engaged in other activities, then
8 conducting our share block, that's very specific.

9 CHAIRPERSON: While we're waiting I just
10 want to get some of that (inaudible). Mic's not working.
11 So we're awaiting battery replacement for the mic that is
12 in the walkway.

13 MR DE VOS: Hello, hello.

14 CHAIRPERSON: Right, here we go.

15 MR DE VOS: Do you hear me? Is this on?
16 I can't hear whether it's on. Thank you, Mr Chairman, and
17 thank you for the new mic. I hope it's going better this
18 time. And let me just recoup because we've now had a
19 little bit of a break. Firstly I say the meeting is not
20 properly constituted. Is it okay? There we go? It's not
21 properly constituted. Secondly I'm saying that the notice
22 is defective. Then I'm saying it's unfair to expect of
23 members all over the country to within two days rectify
24 their proxies or get somebody else nominated to act for
25 them at this meeting and that the 15 days' notice period or

1 the correction of the notice was not given. Okay.

2 CHAIRPERSON: All right. Mr Vos, can I
3 deal with some aspects of what you've had to say? First of
4 all there is no second notice of meeting. There is a draft
5 revised notice of combined meetings which is what would be
6 regarded if we had the correction in time, so the original
7 notice is the notice. There is no second notice. I have
8 pointed out that the omission of the naming of the
9 directors of each of those companies is not material to the
10 notice and I've regarded that as immaterial on that basis.

11 You have started mentioning the rights and obligations of a
12 share block. I would ask you that that is not about the
13 constitution of the meeting. That is about the value or
14 otherwise of a resolution and I've asked you to keep your
15 comments on those items to when we get to the resolution.

16 MR DE VOS: Hello? Can I talk? Okay.
17 Mr Chairman, you see, ja, we can go through all that but
18 the fact of the matter is that we cannot vote on a
19 resolution if it's illegal. Let's get that done now.

20 CHAIRPERSON: So Mr Vos, I don't believe
21 the resolution is illegal. We have a difference of opinion
22 in this regard. So I would ask you to make your comments
23 regarding the constitution of the meeting and the
24 resolution itself we'll deal with when we get to the
25 resolution. I see a question over there.

1 MALE SPEAKER: (inaudible).

2 CHAIRPERSON: Sorry, sorry, could you
3 come to the mic please?

4 MR VAN STADEN: Marius van Staden.

5 CHAIRPERSON: Marius van Staden.

6 MR VAN STADEN: Can we ask that this
7 debate about the legality or not of the constitution be
8 (inaudible) democracy to take place for the members to give
9 their views?

10 CHAIRPERSON: I have a proposal from Mr -
11 can I ask by show of hands those in favour of that
12 proposal? And those against? Mr Vos, the meeting has
13 spoken regarding where we should be doing this. Thank you.

14 MR DE VOS: Mr Chair, let me carry on. I
15 was still talking on the subject of fairness and unfairness
16 and I think you ruled on that point as well and you ruled
17 that (inaudible).

18 CHAIRPERSON: I have not been shown any
19 compelling evidence of any unfairness. The meeting has
20 spoken about how we should proceed and I'd like to observe
21 what the members have indicated.

22 MR DE VOS: Mr Chairman, I hear you.
23 It's your meeting but you must just know (inaudible) that
24 this will have consequences. We are not (inaudible) and
25 what you are doing now is that you create a situation where

1 it is you are trying to rectify the position that you have
2 taken illegally and wrong and therefore we have got a
3 biased quorum and all the (inaudible) and we, our members,
4 has got a real concern about this whole situation. It's
5 unfair and I would like to go on.

6 CHAIRPERSON: Thank you, Mr Vos, for your
7 comments. It's so noted. There are differences of opinion
8 in this regard but your comments are noted and do you have
9 any other points regarding where I am on the agenda and
10 that is the notice?

11 MR DE VOS: All right. Mr Chairman, then
12 we carry on regarding the proxies. There was quite a lot
13 of proxies given to me to act for members and there's quite
14 a proxy given to other people. Why is it not allowed for
15 us to have insight in those proxies and see who gave
16 proxies to whom so that we know where we stand? Because
17 you know exactly who gave proxies to me, Mr Chairman. Why
18 are you privileged above me to know things that I don't
19 know?

20 CHAIRPERSON: So yes, Sir, do you want to
21 go to the mic?

22 MR EBENING: I'm Walter Ebening, 106.

23 CHAIRPERSON: Walter Ebening, 106.

24 MR EBENING: This is just becoming
25 (inaudible). We have a share block where we all agree that

1 we want to protect (inaudible). For you to stand up and
2 make points of order about the legality of the meeting when
3 all of us have travelled here to meet it to delay it is
4 ridiculous. I would like you please to sit down so that
5 this meeting and all the people that have come here to
6 listen, to make a pronouncement on what needs to be done
7 tonight so that we can actually get down to it. I have
8 other things to do.

9 CHAIRPERSON: Thank you. I have a
10 speaker over here.

11 MR BEZUIDENHOUT: Thank you, Mr Chairman.

12 CHAIRPERSON: Close.

13 MR BEZUIDENHOUT: Mr Chairman, can you
14 hear me? How loud must I speak? Can you hear me?

15 CHAIRPERSON: Ja.

16 MR BEZUIDENHOUT: Okay, I'll speak
17 (inaudible). Mr Chairman, my name is Jannie Bezuidenhout
18 from number 60. Can you hear me now? Right. Thank you.
19 I hear what this gentleman was saying here. I am one of
20 the concerned members and I am really, really disappointed
21 to hear that we just have to carry on without being
22 explained what is happening really here. Sir, you do not
23 know what's happening on Ingwelala to be honest with you.
24 Okay, right, can I - we can get to a point where I need to
25 ask some questions.

1 CHAIRPERSON: Mr Bezuidenhout, are your
2 concerns regarding the constitution of the meeting or are
3 they talking about the value of the resolutions?

4 MR BEZUIDENHOUT: No, it will get to the
5 resolution part, Sir.

6 CHAIRPERSON: We're on the constitution
7 of the meeting at this stage.

8 MR BEZUIDENHOUT: Yes, I just want to say
9 -

10 MALE SPEAKER: (inaudible).

11 CHAIRPERSON: Yes, certainly.

12 MR BEZUIDENHOUT: The problem lies with
13 management and things like that that's happening. And at
14 the end of the day as I say I'm not a good speaker maybe
15 but there are some relative points here which I insist - if
16 not then we must take the consequences, all of us, if you
17 do not know and have the facts of what's happening on
18 Ingwelala. I personally believe you do not know what's
19 happening. We're all here to enjoy. We've got our farm.
20 Everybody's part of that share block. We all get there and
21 we all want to go on with our things. But there are really
22 things you do not know and I would love to see or talk
23 about it a little bit later. Thank you.

24 MALE SPEAKER: So Jannie, the beauty of
25 this is that the majority of people elected the board.

1 They elected. I was here. They were elected by us, the
2 majority. It is your right to disagree, absolutely. But
3 it is not your right to affect the rights of the majority
4 of the people.

5 MR BEZUIDENHOUT: I also believe I need
6 to be heard out at the end of the day. I don't, ja, we can
7 discuss that because at the end of the day if I give my
8 reasons for that I'm not here to influence you but I need
9 to get the facts here and then everybody here that doesn't
10 know what's happening, is going on. To be honest with you
11 if I get a chance to speak on this I think some of the
12 people might change their minds. So we're not here to
13 break it down or whatever because what is happening here
14 can cost us millions of rands which we do not really
15 understand it in my perception. Thank you.

16 CHAIRPERSON: Mr Vos. Thank you, Jannie
17 Bezuidenhout, for those comments. There are some
18 fundamental differences in views as there is in any
19 population in any democracy. It doesn't have to be
20 uniform. But Mr Vos, could I ask you to confine yourself
21 to the constitution of the meeting rather than the
22 resolutions? You've heard the popular view so to speak.

23 MR DE VOS: Ja, the popular view, Mr
24 Chairman, will be that we must carry on and I wish we could
25 carry on but it's not my fault that the meeting is not

1 properly constituted. It is your fault.

2 CHAIRPERSON: So I have a disagreement
3 with you.

4 MR DE VOS: What I'm saying, it is not
5 properly constituted. We haven't received enough notice
6 for the amendments and that the resolutions, and I don't
7 mind about resolution 1, I'm talking specifically on
8 resolution 2, 3 and 4 although resolution 1 may be one of
9 the casualties of this whole thing but resolution 2, 3 and
10 4 is not allowed in terms of our constitution.

11 CHAIRPERSON: So Mr Vos, I'm repeating
12 for the last time could you confine yourself to the
13 constitution of the meeting rather than the value of the
14 resolutions? And as the chairman of the meeting I must
15 then ask for support from the meeting to allow the meeting
16 to go forward. All those in favour of the meeting
17 proceeding please raise your hands. And those not
18 proceeding on this basis? So just on a visual basis
19 overwhelmingly, not marginally, overwhelmingly, Mr Vos, the
20 meeting is proceeding. Thank you very much.

21 MR DE VOS: Okay, thank you, Mr Chair.

22 MR RICHARDS: (inaudible).

23 MR DE VOS: Ja, that's a very good point.

24 MR RICHARDS: (inaudible). Sorry, I'm
25 John Richards, 194. You're just going by show of hands but

1 Christo might be sitting with 50 proxies so therefore you
2 better find out before you decide -

3 CHAIRPERSON: Ja, and Mr - and the
4 proxies that are in circulation are for specific
5 resolutions. I'm trying to conduct the meeting and I'm
6 gaining the agreement of the members to the proceedings of
7 the meeting.

8 MR RICHARDS: (inaudible) the right to
9 vote.

10 CHAIRPERSON: We will never know
11 accurately.

12 MR RICHARDS: Well, then you need to do a
13 proper vote.

14 CHAIRPERSON: So let's put it on the
15 record that I did a visual check and overwhelmingly it was
16 yes. I'm now proceeding with the meeting.

17 MR RICHARDS: (inaudible).

18 CHAIRPERSON: The members indicated a
19 desire to proceed.

20 MR RICHARDS: (inaudible).

21 CHAIRPERSON: So just to restate that
22 there is no second notice. There is the original notice
23 and it is entirely possible in terms of the notice that
24 resolutions can be amended by agreement with the members.
25 So the amendments that are being spoken about are the

1 change in the word in resolution 1 authorised from support
2 because support is regarded as willy-nilly, as wide, as
3 vague and authorised is much more consistent. And the same
4 goes to the word support being substituted by authorised in
5 resolutions 2 and 4.

6 So on that basis - and in resolution 1 the
7 wording has been improved by being less vague about which
8 properties in which area so it's very straight forward now
9 whereas previously it was fairly cumbersome as to which
10 properties were - so in effect the resolutions are of the
11 same import. There is the change of the word from support
12 to authorise because we are familiar with what authorised
13 means and we're unfamiliar with what support was in that
14 regard.

15 So I now move to resolution number 1 and I ask
16 for a proposer. Is there a proposer for resolution number
17 1 which is as I've explained to authorise the respective
18 boards of directors of Ingwelala Share Block, Sibon, OP
19 Goedehoop and Buffelsbed together with the Ingwelala
20 companies to make every effort to ensure that the
21 properties owned by the Ingwelala companies are classified
22 as proclaimed, protected areas in terms of the National
23 Environmental Management Protected Areas Act under the
24 umbrella of the Umbabat Private Nature Reserve? Do I have
25 a proposer?

1 MALE SPEAKER: (inaudible).

2 CHAIRPERSON: I have a proposer. You'll
3 get a chance to comment, sir. I have a proposer. Do I
4 have a seconder? Mr Haupfleisch. Are there any comments
5 and debate? Mr Reynolds, could you come to the mic please?
6 Are there some comments regarding the merits? Can I ask
7 the proposer to speak to the resolution please?

8 MR KING: Right, good evening, everyone.
9 My name is Derek King and I was recently elected on the
10 board.

11 CHAIRPERSON: Number 14.

12 MR KING: Bungalow number 14. And I
13 think Bruce Simpson if the members were here in the last
14 meeting would realise how important this resolution is for
15 all of us. It's not about legalese and it's not about how
16 words are put on pieces of paper. It comes down to the way
17 we've constituted the four properties on Ingwelala and two
18 of them currently sit as agricultural land. Now, if
19 anybody's been following the Acts and what is happening
20 around the land position in this country we are at a huge
21 risk of being taxed, of mining permits, of land claims on
22 Sibon and OP Goedehoop and all the board is really asking
23 is to give Bruce Simpson who has a wealth of knowledge on
24 this subject to continue to change those two properties
25 into a protected area.

1 The Kruger National Park is a protected area and
2 they're looking for a buffer zone and they want other
3 protected areas to join in their programme which will allow
4 us to be exempt from taxes, from land claims, from
5 municipalities that are looking for rich, white areas. So
6 we either pack up now or we vote for this resolution so
7 that we can give the board members the permission or the
8 authorisation to continue to change OP Goedehoop and Sibon
9 into a protected area. If there's any uncertainty about
10 what this means and what we need to do it's - we can
11 discuss it at length afterwards but it is something that
12 I'm begging you as a member of Ingwelala and as a new board
13 member please support us because this is the single biggest
14 risk that we have at Ingwelala right now and we need your
15 support. Thank you.

16 MR DE VOS: Christo de Vos, 87 again. Mr
17 Chairman, thank you. Contrary to popular belief I'm in
18 favour of this resolution so you can relax about that one.

19 CHAIRPERSON: Thank you.

20 MR DE VOS: The problem I have is the
21 question is actually why have we not been part of the
22 protected area yet. What has happened, and I'm sure you
23 will explain to us, that's not going to change my vote.
24 And the other problem I have, if I vote in favour of this
25 do I then acknowledge that this meeting is properly

1 constituted or don't I? And I've got a lot of proxies so -

2 CHAIRPERSON: Mr Vos.

3 MR DE VOS: If I can vote on this - no,
4 hear me out. If I can vote on this but I reserve my rights
5 in respect of the, my alleged, my allegation that this is
6 not properly constituted because the meeting is not
7 properly constituted but just for us to go forward we need
8 to do something in this vote and I cannot, I cannot, I've
9 got proxies of 30/40 people. What I actually would've done
10 if I was alone here, I would've walked out but I can't do
11 that because I'm proxied by people to represent them on
12 vote. So this is my dilemma. So under those provisions I
13 will vote in favour.

14 CHAIRPERSON: Thank you, Mr Vos. That's
15 great support. I'm not able to answer your legal question
16 regarding the question you asked. I am able to say that as
17 far as I'm concerned the defects in the original notice
18 were not material and I've asked the members if we can
19 proceed on that basis. Are there any other questions or
20 comments on resolution number 1?

21 MR HUTTON: Are there any reasons why
22 anybody should not vote yes to this resolution? Bungalow
23 number 35, Martin Hutton. Are there any reasons, John, why
24 anybody should not want to vote yes to this resolution?

25 CHAIRPERSON: I can't think of one.

1 MR HUTTON: If anybody knows of any
2 reason why we shouldn't vote yes to this would they say so
3 at this meeting?

4 CHAIRPERSON: So it sounds like a
5 wedding. Sir, could you come to the front?

6 MR ERASMUS: Mr Erasmus, 159. I just
7 want to ask one question. In the meeting we had last week
8 or last, on the 8th of June they mentioned that there's a
9 dispute and if you agree to - if there's a dispute you
10 cannot be proclaimed as a nature reserve.

11 CHAIRPERSON: Okay, I heard in the board
12 meeting this afternoon.

13 MR ERASMUS: Okay.

14 CHAIRPERSON: That as long as the three
15 partners or the three people that collectively own OP
16 Goedehoop in an undivided nature sign the required
17 documents whether they love each other or hate each other
18 it's fine. It doesn't have to - so it's within OP
19 Goedehoop. It doesn't affect anything. The outside
20 boundaries are still fine so it's not an issue.

21 MR ERASMUS: Okay, so it does not affect
22 the dispute.

23 CHAIRPERSON: No. It's not an issue.
24 Thank you. Any other comments on the resolution? All
25 right. I would then ask you - there is a comment.

1 MR DE VOS: Just, Mr Chairman, it's
2 Christo de Vos, 87 again. Just Mr Chairman, so that you
3 understand I've got proxies there from members who gave me
4 instructions to vote against this and this is the dilemma
5 because we haven't had enough time to consult with the guys
6 and get new instructions.

7 CHAIRPERSON: Ja.

8 MR DE VOS: Some of them gave me revised
9 proxies but I couldn't contact everybody so you see the
10 predicament we have?

11 CHAIRPERSON: So it is what it is, Mr
12 Vos, I'm afraid. All right. So I then put by ballot
13 ordinary resolution number 1 to the vote. You have the
14 papers with you. Please mark resolution 1 on each of the
15 companies that you are entitled to vote on which was
16 determined at registration. I now have the numbers of
17 persons present by person or by proxy so of the 1 500
18 shares in Ingwelala 1 043 are present which is just over 67
19 or 68%. In respect of Buffelsbed 143 of the 209 are
20 present in person or by proxy. That is two thirds roughly
21 or almost exactly. OP Goedehoop's 142 of the 200 members
22 of OP Goedehoop are present which is just under 75%. And
23 138 of Sibon's 196 members are present in person or by
24 proxy which is approximately 70%. So in effect it means
25 that there's a huge representation of members of the

1 companies at Ingwelala. Before I go to resolution number
2 2, Mr Reynolds, will you come to the mic please?

3 MR REYNOLDS: Philip Reynolds, bungalow
4 52. Just a technical question on we are seeking this legal
5 work to be done on Sibon and Goedehoop. Why are we voting
6 on Ingwelala and Buffelsbed on it if it doesn't affect them
7 because they already proclaimed?

8 CHAIRPERSON: Because the proclamation
9 that is to come will be of the combined entire area and
10 will be a re-proclamation in respect of those items under
11 current legislation under the current National
12 Environmental Management Act of 2003. The proclamation
13 that exists for Ingwelala and Buffelsbed is of old
14 legislation so it's to perfect the legislation. All right.
15 Moving on to ordinary resolution number 2.

16 MALE SPEAKER: (inaudible).

17 CHAIRPERSON: So Mr Vos has asked when is
18 he going to tick all these boxes because he's got a whole
19 pile of these things. So Mr Vos, I think you need to do
20 your best and we will accommodate you as best as we can.
21 So ordinary resolution number 2 is as we said originally
22 was to support. It's now to authorise the boards of
23 directors of the Ingwelala companies to create a trust to
24 address matters ancillary to the main objects and purposes
25 of Ingwelala in supporting communities adjacent to and

1 within the properties owned by the members of the
2 Association of Private Nature Reserves Conservation Areas
3 and to support biodiversity and conservation in particular
4 anti-poaching members within the ANPR conservation area and
5 to do all such things necessary to give effect thereof.

6 So I'm the proposer of this resolution. Do I
7 have a seconder? Mr Visi, thank you. So let me talk to
8 this resolution. In part this resolution does exactly what
9 Mr Vos has asked us to do is that matters which he believes
10 are not part and parcel of the authority of Ingwelala Share
11 Block to do needs to be done because we want it done
12 because it supports our actions with the neighbouring
13 communities in support of our efforts to, with the
14 Bushbuckridge Municipality to have amelioration of the
15 likely rates that are coming.

16 It's important to do good works in our community
17 and these good works could be from any number of
18 fundraising activities to environmental education amongst
19 our community and communities adjacent to our protected
20 areas. It is arguable that some of these activities cannot
21 be done by a share block company and therefore it is
22 intended to create a trust outside of Ingwelala but create
23 the trust separately and independently of Ingwelala in
24 order to do these things that it is arguable, not always
25 agreeable, is arguable are not capable of being done in

1 Ingwelala. And that is the purpose of the resolution.

2 This trust will be outside of Ingwelala. It will not be
3 accountable in the Ingwelala books.

4 It will be a separate entity with a separate
5 board of trustees yet to be identified and when identified
6 by volunteering they will need to produce the trust deed a
7 draft of which exists already and it will be independent of
8 Ingwelala. If that trust wishes to conduct activities on
9 Ingwelala property, for example a water polo match or a 4X4
10 safari type activity or environmental education or
11 whatever, it will need to have permission to access the
12 Ingwelala properties in this regard. This trust will need
13 permission in order to use the land of Ingwelala in any of
14 the facilities and that is the purpose of the trust.

15 Hello, Mr Vos.

16 MR DE VOS: Thank you, Mr Chairman. I'm
17 back here again. Christo de Vos, 87. Mr Chairman, if this
18 is outside Ingwelala and outside our domain why do we need
19 to have a resolution to vote on that?

20 CHAIRPERSON: So the reason, Mr Vos, is
21 transparency. It's that for the members of Ingwelala to
22 know that the trust exists and that it won't be in
23 Ingwelala, that these activities will be outside of
24 Ingwelala. It's a good point but the rationale for the
25 resolution is transparency so that members will know that

1 these types of activities are not taking place in
2 Ingwelala, that capable be taking with, not taking place in
3 Ingwelala without permission, in other words Ingwelala
4 doing it. If the trust wishes to do it the trust needs to
5 ask for permission to do it. That is the person.

6 MR DE VOS: Ja, Mr Chairman, now I've
7 seen that draft trust and I saw that Ingwelala will be the
8 founder of the trust. Is that still the intention to do
9 that?

10 CHAIRPERSON: It is entirely changeable.
11 Personally it can be the trust. It was drafted by myself
12 with Ingwelala was the trust. This was six months back or
13 so. So it's entirely changeable from that point of view.
14 The resolution indicates that Ingwelala is to create the
15 trust, in other words be the founder, not the controller.

16 MR DE VOS: Mr Chairman, on that point we
17 are not allowed to do that in any case. So if you say it's
18 going to completely outside, be completely outside
19 Ingwelala let's then rule that whoever wants to create the
20 trust let them go and create the trust. I've got
21 absolutely no objection to that.

22 CHAIRPERSON: Great. We will change the
23 -

24 MR DE VOS: But we cannot use, we cannot
25 use Ingwelala's name. You cannot use Ingwelala's property.

1 You cannot use our assets and you cannot use our staff
2 without prior permission.

3 CHAIRPERSON: Correct.

4 MR DE VOS: And then the question will be
5 who's going to grant that permission. Is it going to be
6 the board of directors or are you coming to the members?

7 CHAIRPERSON: It's going to be the
8 elected by the members board of directors.

9 MR DE VOS: But I still contend that it's
10 ultra vires for us to vote on something that's got
11 absolutely nothing to do with us.

12 CHAIRPERSON: Your point is so noted.
13 Some comments. Mr Cochran.

14 MR COCHRAN: I must agree with Mr Vos.
15 My name is (inaudible) Cochran. I'm a member of 75. I
16 agree with Mr Vos. As soon as there's anything from
17 Ingwelala that has anything to do with this trust Ingwelala
18 is involved. You will look - you said the board is going
19 to appoint the trustees.

20 CHAIRPERSON: No, I didn't say that.

21 MR COCHRAN: Okay, well -

22 CHAIRPERSON: We will seek volunteers to
23 be trustees of the trust, interested, agreeable individuals
24 that will not be -

25 MR COCHRAN: But who's we? All Mr Vos is

1 saying, anybody who wants to form a trust for the purpose
2 go and do it but don't have anything to do with Ingwelala.
3 Otherwise I can guarantee you whatever happens in the
4 future somebody's going to be looking to get it back to
5 Ingwelala. So there must be a total, total divorce if I
6 can put it that way.

7 CHAIRPERSON: I agree. That is the
8 intention.

9 MR COCHRAN: Okay. As long as that's the
10 intention.

11 CHAIRPERSON: Yes.

12 MR COCHRAN: Obviously if anybody wants
13 to do that that's fine as long as it doesn't involve
14 Ingwelala in any way.

15 CHAIRPERSON: Mr Cochran, it's very
16 important that it is not attachable to Ingwelala because if
17 it was attachable in some way Ingwelala's financial
18 statements would have to include the affairs of that trust.
19 That's something we wish to avoid.

20 MR COCHRAN: (inaudible) as long as we
21 understand that this trust is going to have nothing
22 whatsoever to do with Ingwelala.

23 CHAIRPERSON: Without the permission of
24 the Ingwelala arrangements. Thank you. Sorry, do I have
25 someone at the mic? Mr Reynolds, are you coming to the

1 mic?

2 MR REYNOLDS: Just a question to Mr Vos
3 and to you. Is it illegal for Ingwelala to do good deeds
4 on its own? Why can we not as a share block company as
5 part of maintaining the company and the goodwill of the
6 company donate money to the school or to whatever? Ja, I
7 mean, why do we need a trust for that or is the trust to
8 own the aeroplane?

9 CHAIRPERSON: No, the trust's purpose is
10 to do good deeds. One of them may well be the aeroplane if
11 the trustees so agree from that point of view. So the
12 trustees need to run their own business. Can Ingwelala do
13 good deeds? I'm telling you that the impression I'm
14 getting from Mr Vos is that it is outside of the Share
15 Block Act for Ingwelala's powers.

16 MR REYNOLDS: But of course we disagree.

17 CHAIRPERSON: Sir.

18 MALE SPEAKER: (inaudible), bungalow 9.
19 Maybe you can just help me. You say the reason that you're
20 bringing this resolution is in the interest of
21 transparency. I think transparency is served by you
22 suggesting this at the AGM. I don't think it's necessary
23 for a resolution of the members authorising the setting up
24 of a third-party trust. It really just doesn't make any
25 sense to me. You've been transparent and you've said

1 certain members may or may not go and set up a trust to do
2 good deeds. That's fantastic. I don't understand the
3 nexus between that and us passing a resolution saying you
4 can go and do it because in effect what we're then doing is
5 authorising. Whichever way you seek to couch it by voting
6 on a resolution we're authorising the establishment of a
7 trust and you're saying there's no nexus between the two as
8 far as authorising it.

9 CHAIRPERSON: So the original, thank you,
10 Sir, the original resolution says, so the original
11 resolution said support which was vague and non -

12 MALE SPEAKER: Just answer my question.

13 CHAIRPERSON: Ja, so I agree with you.
14 So it is really for transparency rather than authorisation.

15 MALE SPEAKER: (inaudible).

16 CHAIRPERSON: Okay. So I have that view
17 with you. Any other comments?

18 MALE SPEAKER: Why do we still vote then
19 on it?

20 CHAIRPERSON: So the question is why do
21 we so vote and I would really have to ask the meeting does
22 the meeting feel that there's a need to vote on this. Any
23 yeses? Any nos? All right. The resolution is withdrawn.
24 Thank you very much. It's withdrawn on the basis what
25 we've heard the discussion that the, it is encouraged to do

1 good deeds and Ingwelala is outside of the trust
2 arrangements but will co-exist on a side by side
3 arrangement in that regard. Ordinary resolution by
4 agreement of the members is withdrawn.

5 We now move to ordinary resolution number 3. The
6 members accept with grateful thanks the donations made in
7 cash and kind already received and pending and as
8 transferred to the company Project Skywalk (Pty) Ltd for
9 the acquisition of the light aircraft Savanna Light Sport
10 Aircraft ZUETD which company is currently non-beneficially
11 owned by two Ingwelala directors pending the formation of
12 the trust envisaged in resolution number 2. I'm the
13 proposer of this resolution. Is there a seconder? Mr King
14 of number 14.

15 Now, the reason for this resolution is we do have
16 these donations and they have been used for a purpose and
17 at the insistence of Mr De Vos and others this aircraft is
18 deemed by those arguing the case not capable of being owned
19 by a share block company and furthermore not being capable
20 of being owned by Sibon (Pty) Ltd and for this reason this
21 aircraft is transferred out of the Ingwelala environment,
22 sold to Project Skywalk which exists in paper.

23 As we've indicated in the proposal form two
24 current Ingwelala directors are the nominated directors and
25 shareholders of this company pending the proper ownership

1 by a trust to be formed. We have signed blank deeds of
2 transfer, share transfer forms and we have signed deeds
3 describing that we are not the beneficial owners of this
4 aircraft. And again for transparency reasons this is
5 brought to the members so that you understand and can voice
6 your opinions that this aircraft is not as we stand at the
7 end of June and now this aircraft is not in the Ingwelala
8 domain but in the domain of a separate entity pending the
9 formation of that trust. That is the purpose of the
10 resolution, transparency again. Do I have some comments?

11 MR DE VOS: Thank you, Mr Chairman,
12 Christo de Vos. I'll try not to bore you. Mr Chairman,
13 for me it's obvious that the board has not given much
14 thought to the impact and effect of this resolution. The
15 members are requested to accept with grateful thanks the
16 donations made in cash and kind. Now I don't know which
17 companies' members does this resolution refer to. The
18 meaning "in kind" needs to be explained.

19 Furthermore before we can thank anyone for any
20 donation we at least need to know who the donors are. Why
21 are the identities of the donors such a secret, Mr
22 Chairman? We've asked on various instances for them to be
23 identified. Why have I not been able to talk to any of
24 those okes and hear their argument? Maybe they've got a
25 very good argument why they did it and maybe they could've

1 persuaded me. But the platform is not created for us
2 members to talk to each other. And any request that we ask
3 please distribute this letter amongst the members is not
4 being adhered to by our board. But let me go on -

5 CHAIRPERSON: So let me ask.

6 MR DE VOS: No, let me carry on.

7 CHAIRPERSON: Let me ask some, answer
8 some parts of your question.

9 MR DE VOS: No, this is now my turn to
10 speak so you'll get yours just now. Why are the identities
11 of the donors such a secret? This raises all sorts of
12 questions such as did the Ingwelala management and the
13 board comply with the FICA regulations in relation to the
14 receipt of the money? Are the donors doing any business
15 with Ingwelala such as supplying material, stock or
16 services? Do any of the donors intend to fly the aircraft
17 under the disguise of an anti-poaching operation and expect
18 the Ingwelala members to foot the bill? To me absolutely
19 honesty and transparency are crucial and you're trying to
20 say that you are transparent, Sir, but obviously you are
21 not so transparent.

22 What also needs to be considered is the 20%
23 donations tax payable on all donations made. As I
24 understand it the sequence of events for the donations for
25 the aircraft is as follows. Firstly the donors donated

1 R450 000 to Ingwelala Share Block Company and so the donors
2 have to pay 20%. That is R90 000 donations tax. Secondly
3 Ingwelala Share Block Company donates the aircraft to
4 Sibon, value R450 000. Ingwelala Share Block Company needs
5 to pay R90 000 donations tax. Thirdly Sibon donates the
6 aircraft to Project Skywalk, value R450 000. Sibon needs
7 to pay R90 000 donations tax. Total donations tax payable
8 is R270 000.

9 Have all these tax obligations been accounted
10 for? In my view it is short-sighted, Mr Chairman, to start
11 accepting donations. We should rather decline the
12 donations so that the initial donors can get their money
13 back and if they wish donate the money to Project Skywalk,
14 the ultimate owner of the aircraft. If Project Skywalk is
15 totally alone standing as the board alleges and the
16 donations are declined by the Ingwelala companies the
17 identities of the donors are irrelevant to me. But if
18 Project Skywalk however is or becomes part of Ingwelala
19 domain we as shareholders are entitled to know who the
20 donors are and for that reason I will vote against the
21 resolution, Mr Chair.

22 CHAIRPERSON: Thank you, Mr Vos. So the
23 answer to your three questions is no, no, no. The reason
24 that you are not able to see who the donors are is matters
25 of privacy, requested privacy by the donors. I can assure

1 you, you may not like the assurance but I can assure you
2 that there is no impropriety or related party in the
3 relationship between any Ingwelala company and the donors
4 other than these members. Specifically the donors,
5 specifically the large ones and I cannot tell you who they
6 are because I have not seen, studied the list and cannot
7 recall, I can tell you that there are three largish
8 donations and the rest are made up of large numbers. The
9 numbers of what has been donated have been put into the
10 proposal in other communications in that respect.

11 On the question of donations tax the donation
12 made by the individuals is in respect of their own
13 environments and their own taxes if applicable in their own
14 environments. Section 18A, deductions are not capable of
15 being claimed by these individuals. They made these
16 donations without the capability of claiming a tax donation
17 for the donors, for the donation and which makes it all the
18 more remarkable how the donations were made. The transfer
19 of the aircraft from Ingwelala via Sibon to Project Skywalk
20 is a transfer. It's not a series of donations. And in
21 that regard Project Skywalk will have to account for the
22 asset that is has received. Are there any further
23 questions?

24 MR DE VOS: Mr Chairman, so we will be
25 getting the financials one of these days and there will be

1 no donations tax payable by any one of the companies of
2 Ingwelala. Is that what you're saying?

3 CHAIRPERSON: Correct. All right.

4 MR DE VOS: But in any case -

5 CHAIRPERSON: Sorry, Mr Cochran has a
6 question. Sorry, Mr Vos, do you want to finish your
7 question?

8 MR COCHRAN: I think it's been covered.
9 I'm not an accountant but these were - I was asked to pose
10 these questions to the meeting but I just ask you, Mr
11 Chairman, which I know you will do, will you respond to
12 that man to the extent they haven't been dealt with in this
13 meeting because they're all very technical tax questions
14 with donations as well.

15 CHAIRPERSON: Thank you. Subsequent to
16 the meeting or now?

17 MR COCHRAN: Ja, subsequently.

18 CHAIRPERSON: Thank you. Mr Vos.

19 MR DE VOS: Mr Chairman, again if the
20 resolution has got absolutely nothing to do with Ingwelala
21 and the money is actually sitting in Project Skywalk I
22 suggest that the two owners of Project Skywalk pay their
23 respects to the donors and say thank you very much. Then
24 furthermore if you want to do some advertising and things
25 for Ingwelala won't it be a good idea if the aircraft was

1 donated to some or other organisation outside Ingwelala
2 like the Greater Kruger National Park or any of those anti-
3 poaching organisations and we could've painted our name on
4 it and say this was donated by Ingwelala. It would have
5 been far more accepted, acceptable to all the members. We
6 don't want the aircraft and we don't want to say thank you
7 for donations we don't need.

8 CHAIRPERSON: Thank you, Mr Vos. We will
9 certainly put that suggestion to the relevant authorities
10 in this structure.

11 MR BEZUIDENHOUT: Thank you, Mr Chairman.
12 It's Jannie Bezuidenhout again from number 60. I would
13 just like to pose a couple of questions regarding - and I
14 think it's in line with resolution 3 and 4 because both of
15 them are linked to the aircraft. You spent roughly about
16 R65 000 on the report which covers mostly Umbabat. If you
17 look at the details in your report you mentioned there, you
18 know, a consideration for the farms and consideration. You
19 mentioned a figure of R810 000 per year for rangers and
20 guys like that that needs to be put. You pulled it right
21 back to Ingwelala but you said the R810 000 must be part of
22 Umbabat. How can you put it down to Ingwelala's members
23 whilst it is covering the whole of Umbabat?

24 CHAIRPERSON: So can I answer that
25 question before you go to number 2? Ingwelala is a funder

1 of Umbabat together with the other members of Nkorho and
2 Wilderness Conservation, Umbabat Wilderness Conservation.
3 So if there are costs at the top they will seek to recover
4 it from down the line.

5 MR BEZUIDENHOUT: Okay, my question is
6 what are their contributions because the R810 000 you've
7 put right down to all the members of the share block.

8 CHAIRPERSON: So the contributions of
9 Ingwelala to Nkorho which is where we are the member is
10 done on a per hectare basis together with the other share
11 blocks in our area.

12 MR BEZUIDENHOUT: Okay, but again I'm
13 coming back to the question. While you were talking about
14 the equation you take R810 000 for the whole of Umbabat
15 which is roughly about 18 000 hectares and Ingwelala is 16%
16 of that, 3 000 hectares. Now, you write the cost down
17 right to the 3 000 hectares. What about the balance?

18 CHAIRPERSON: So I think the example of
19 810 000 is the equivalent number of rangers if you take the
20 space, one ranger per, is it 10 000 hectares or 15 000? So
21 it's not an equivalent basis so there's no suggestion that
22 Ingwelala will pick up R810 000 as an example.

23 MR BEZUIDENHOUT: Yes, you've mentioned
24 that in the report.

25 CHAIRPERSON: Yes.

1 MR BEZUIDENHOUT: (inaudible) the
2 shareholders will be R323 if needed.

3 CHAIRPERSON: So the -

4 MR BEZUIDENHOUT: Can I just finish? You
5 tried to motivate the aeroplane by boosting the share block
6 holders and scaring them that an additional R323 needs to
7 be paid which I'm not happy with. Secondly, you know,
8 you've mentioned here in your report, the first report of,
9 the thick one before the questions, answers, that the
10 aircraft you've approved is covered by donations the first
11 year on maintenance. Then you've said later on that in the
12 budget of conservation and security the maintenance of the
13 aircraft can be covered. But later on in your last
14 (inaudible) you said no maintenance will be paid to the
15 aircraft. All will be done by donations. So that is a
16 problem for me also.

17 CHAIRPERSON: So the aircraft will be in
18 the trust after that and if Ingwelala wishes to use the
19 aircraft it would have to come maintained. So the
20 intention is that if Ingwelala wishes to have air support
21 for its own purposes it would have to acquire that air
22 support from somebody and that's what the number is.

23 MR BEZUIDENHOUT: Okay. Sir, but the
24 problem is here for me also is that you explain here that
25 you want to use the aircraft for Ingwelala. Once you've

1 taken off with the aircraft you cover now a couple of, when
2 you reach altitude you cover like Timbavati, Klaserie,
3 Motsware, whatever. The contribution, now you said there
4 are intentions and interests in -

5 CHAIRPERSON: Recovering the costs from
6 other reserves.

7 MR BEZUIDENHOUT: Ja. Now why didn't you
8 when you did the due diligence, why didn't you first tie up
9 all the legal documents because as I've said, you know, I'm
10 interested in buying a Lamborghini but I've shown that at
11 the end of the day a Volkswagen Polo did the job. So by
12 saying that we will now try and enter into an agreement is
13 just not on.

14 CHAIRPERSON: So the answer to that is
15 it's actually quite impossible to go to an organisation and
16 say if we have the aircraft, please sign here that if we
17 have the aircraft this will be the arrangement. So the
18 intention - so in other words we need to get the permission
19 to use this aircraft and do as we've described in there
20 before we can tie up legal agreements with anybody.

21 MR BEZUIDENHOUT: Ja. The further
22 question is also there's a ZU ops on standby which begs
23 everybody to be used for free. Now we have to buy an
24 aeroplane, carry the cost. The legal implications that we
25 might have is - and you've said very vaguely in your report

1 we get indemnification from the pilot. Now, two of our
2 staff members would fly that. First of all if that
3 aeroplane takes off he indemnifies us. What happens if
4 that aeroplane falls or gets shot down in Timbavati,
5 crashes in a lodge? We've got third-party claims. You've
6 got family claims. Remember they have not indemnified
7 Ingwelala. You open us up for millions of rands of claims
8 by civil suit. And I'm not a legal expert here. I'm just
9 - that's my opinion here. If that plane comes down you've
10 got no reaction whatsoever or control over the poacher
11 which you are hunting or what you call it, air surveillance
12 or whatever. So if that plane gets shot down. We open us
13 up for major, major legal costs.

14 CHAIRPERSON: So can I answer a couple of
15 parts in that? So ZU ops status has changed. The provider
16 of that aircraft has taken it back. It's no longer
17 available on that basis. It's something we learnt in the
18 board meeting today. So it's a disappointment from that
19 point of view. In terms of risk and the pilots these
20 individuals volunteer. They understand the dangers. The
21 individuals who fly which are not necessarily those two
22 pilots, there could be other volunteers, pilots understand
23 the risks. They fly already. They understand the risks of
24 associated with aviation and that is what we are relying
25 on.

1 MR BEZUIDENHOUT: You're talking about
2 now - I'm mainly aiming at our staff members that's
3 involved, Joubert and John Llewellyn. Number 1, the
4 reaction time, you've mentioned in your report that we
5 might get a hangar for gratis in a neighbouring farm. If a
6 shot is fired and a call comes through by the time Joubert
7 reacts, gets to the neighbouring farm, do his pre-checks,
8 pulling the aeroplane out of the hangar etcetera, etcetera,
9 by the time he reaches altitude that guy is already
10 drinking a beer in Phalaborwa.

11 CHAIRPERSON: Okay. So the first purpose
12 of this aircraft is not hot pursuit. The first purpose of
13 this aircraft is a deterrent. Knowledge that the aircraft
14 exists and can get airborne is the biggest asset of it that
15 it is a deterrent to poachers. Go somewhere else. Don't
16 come here. That is the purpose. So it's not hot pursuit.

17 MR BEZUIDENHOUT: With all due respect
18 our anti-poaching or our poaching rate in Ingwelala is
19 practically nil. If you go and have a look at the poaching
20 figures next to us it's much higher because a poacher and
21 all of us driving around enjoying our farm are the
22 deterrent, not the aeroplane in the air.

23 CHAIRPERSON: So this aircraft is not
24 limited to flying within Ingwelala's boundaries. We're
25 part of the Nkorho. We're part of the Umbabat. And it's

1 flying in those areas, will be at the request of those
2 management authorities with a hopefully proper sort of
3 compensation for that.

4 MR BEZUIDENHOUT: But again hopefully.

5 CHAIRPERSON: Ja, well, we can't -

6 MR BEZUIDENHOUT: (inaudible) question
7 marks but already we have to commit ourselves with
8 something which might be of great danger and expense to our
9 company. For example I went a bit and so some groundwork
10 whilst I was there on my last time. We are interesting in
11 flying around, we, the board and whoever the sky project
12 is. What about our ground troops? You cannot do air
13 surveillance up in the air and there's no ground troops.
14 I've been to the APU offices. To be saying to you loud and
15 clear, pathetic. Our instruments are gone. Vehicles are
16 broken. The guys can't radio. GPS batteries are flat in
17 such a way that they've cancelled the agreement with
18 Ingwelala or the Umbabat group. Now, so this is very, very
19 dangerous.

20 CHAIRPERSON: So let me just clarify.
21 You're saying the APU equipment is out or the Umbabat's
22 equipment is out?

23 MR BEZUIDENHOUT: Well, Umbabat but
24 remember one thing now. They have to go through
25 Ingwelala's warden because of the fact that they, if they

1 want to require something -

2 CHAIRPERSON: Umbabat's warden which is
3 Ingwelala.

4 MR BEZUIDENHOUT: Umbabat's warden, ja,
5 which is Mark. Everything gets stopped there. I have
6 proof of things that's been stopped and there's a lot of
7 irregularities happening between APU and our warden which
8 means Ingwelala in such a way that they're withdrawing
9 their services. But in the end of August they've just
10 resigned.

11 CHAIRPERSON: So for a clarification, Mr
12 Bezuidenhout, Umbabat's security service provider, the
13 Entumeni rangers, have given notice of the termination of
14 the Entumeni rangers' service. Umbabat board or management
15 authority is going to appoint someone else after the end of
16 August.

17 MR BEZUIDENHOUT: What is the reasons for
18 that?

19 CHAIRPERSON: Dissatisfaction with the
20 service levels provided by Entumeni rangers.

21 MR BEZUIDENHOUT: I do not believe you,
22 sir, with all due respect. All due respect, I do not
23 believe you. I've gone out there and I think everybody
24 here that's on the ground, I think everybody can believe
25 that we had good service because of our poaching rate is

1 basically nil all over the place. I've been told by the
2 rangers that shots are fired. Our warden is supposed to be
3 24 hours on standby. He must answer his radio because that
4 with him is a channel. He doesn't answer his radio.
5 They've got no vehicle. The ranger must get on a bicycle
6 to inspect the shots. When he gets to some of the shots
7 apparently one of the issues was a next door farmer who
8 shot a, without a permit, an impala putting the impala
9 behind him to get satisfaction of the hyenas at the end of
10 the day. That gets reported to our warden and he does
11 nothing about it.

12 CHAIRPERSON: So the incident you're
13 talking about is that the neighbour did have a permit to
14 shoot an impala.

15 MR BEZUIDENHOUT: Expired permit, sir.

16 CHAIRPERSON: A week earlier and didn't
17 use it. Fired, ja.

18 MR BEZUIDENHOUT: Expired permit.

19 CHAIRPERSON: He's used an expired permit
20 a week later. That's quite correct.

21 MR BEZUIDENHOUT: That's right. So
22 expired permit is no permit, sir.

23 CHAIRPERSON: Umbabat summoned air
24 support.

25 MR BEZUIDENHOUT: The fact remains is and

1 we can - and I challenge everybody here. The Endumeni
2 rangers are prepared to stand up against this because of
3 the fact that we as members do not know what is happening
4 on the ground. Now my point is you are mentioning here
5 about our contribution to the conservation and security.
6 You want to use it for maintenance in the aeroplane. Where
7 is the contribution to the APU unit? Where is the - for
8 the radios, the vehicles etcetera?

9 CHAIRPERSON: We pay several hundred
10 thousand rand to Nkorho and to Umbabat for services.

11 MR BEZUIDENHOUT: Why doesn't it get
12 approved by the warden?

13 CHAIRPERSON: So we will have to enquire
14 along the allegations of what you're talking about.

15 MR BEZUIDENHOUT: But you're welcome.
16 I've got -

17 CHAIRPERSON: Thank you. We will make
18 use of your insight in this regard.

19 MR BEZUIDENHOUT: That is one of the
20 problems that I've got with it. You were talking about the
21 standards of the, international standards about rangers. A
22 certain formula is used. Now show me on the international
23 standards because based on that you were talking about
24 R810 000 for the Umbabat. Does it state in the
25 international standards that if you've got an air

1 surveillance in the air that we can lower our ranger
2 (inaudible), that we can cut back to two or three or four
3 because we've got air surveillance?

4 CHAIRPERSON: So that is the construction
5 of the argument we've put in there that air surveillance
6 makes it unnecessary for that number of rangers on the
7 ground.

8 MR BEZUIDENHOUT: No, it is not true. I
9 can tell you now -

10 CHAIRPERSON: Difference of opinion.

11 MR BEZUIDENHOUT: The fact remains the
12 international standards says you need, let's call it a
13 figure, 15 rangers. That is the international standards.
14 It doesn't say if you've got ten aeroplanes in the air that
15 you can cut back to two or three. You're talking about -
16 so I'm just trying to read here a bit more.

17 CHAIRPERSON: Okay. We have a speaker
18 behind you.

19 MR BEZUIDENHOUT: You're welcome. Okay.
20 Then I reserve the right to carry on.

21 CHAIRPERSON: Thank you.

22 MR DE VOS: Thank you, Mr Chairman.
23 Christo de Vos, 87 again. I propose that we withdraw
24 resolution 3 so that we can get on with the meeting because
25 it's obvious that the donations cannot stay in Ingwelala

1 and that it must go to some other entity.

2 CHAIRPERSON: I have a speaker behind
3 you.

4 MR WESSEL: Chairman, thank you. Andre
5 Wessel, 66. Just a small point, I'm a private pilot for 30
6 years now. I've still got aircraft. I'm current. Mr
7 Chairman, when you fly an aircraft and you're flying low
8 and slow you are near death. Your pilot has to keep the
9 aircraft in control and watch his speed very carefully. So
10 we have an aircraft. We're doing observation. The pilot
11 does no observation. The only person in observation is the
12 co-pilot or the passenger. The (inaudible) is in front.
13 You can only see 20 degrees to the right of the (inaudible)
14 to 70 degrees back.

15 So your coverage from 360 degrees is about - what
16 is the difference? 50 degrees, 60 degrees. If somebody
17 sees somebody on the ground - now I've been flying 30
18 years. If you fly at 1 000 foot an elephant looks like an
19 ant. If you see somebody the pilot cannot turn immediately
20 to confirm what he saw because if you turn immediately you
21 once more come straight back onto the target. Then you
22 can't see the target because the target is in front of the
23 (inaudible). You have to fly 30 seconds ahead. You have
24 to do a full minute turn. You have to do 30 seconds back
25 and by the time the person wants to confirm there was

1 movement you will see nobody. The plane makes a noise.

2 What are we doing, Mr Chairman? We're playing games.

3 CHAIRPERSON: So if I could say to you
4 that the required authorities at the Hoedspruit Wildlife
5 Authority, the air wing are going to certify. The plan is
6 that they would certify certain pilots for this purpose and
7 they would train them. They would examine them and they
8 would only allow them to fly the plane in their environment
9 on that basis as they were trained. But thank you for your
10 observations.

11 MR WESSEL: On that point, Mr Chairman,
12 it'll probably take our team of staff about five years to
13 get there.

14 CHAIRPERSON: I understand that will be -

15 MR WESSEL: So what are we doing? The
16 other point is that - and this is - if you go onto Google
17 you'll find it. The most dangerous flying that you can get
18 and this is proved by accidents and deaths is conservation
19 flying. It is the most dangerous.

20 CHAIRPERSON: It is dangerous.

21 MR WESSEL: Knowing that we put our staff
22 on there and you tell me that they fall and die and there's
23 no claim. Absolutely rubbish. There will be a claim.
24 Their family will come -

25 CHAIRPERSON: We've not said there'd be

1 no claim. We wish them - they are volunteering.

2 MR WESSEL: Mr Chairman, we should be
3 saying to them don't do it. We don't allow you to do it.
4 It's too dangerous. Not say, okay my mate, get on the
5 plane and kill yourself. They're coming for you.

6 CHAIRPERSON: Thank you.

7 MR GILL: Mr Chairman, Kevin Gill, 51. I
8 think we're losing sight of an important point and that is
9 there are two completely different identities, different
10 legal bodies, Ingwelala Share Block Limited and a trust
11 which owns an aeroplane. If X is employed by the trust to
12 fly the insurance and other consequences, all the rest, are
13 the problem of the trust, not Ingwelala.

14 CHAIRPERSON: Thank you. So are there
15 any other comments? Ja.

16 MR DESTEL: My name is Gaem Destel. I'm
17 unit 18. I want to share with you all, not that I'm
18 wishing that on anybody, that I had a very nice dentist by
19 the name of Dr Harry de Wet. I don't know if anybody here
20 knows him. Ja, okay. He was a pilot for many years. He
21 was a pilot for many years, an excellent dentist and a very
22 good friend. He had 100, maybe even thousands of hours in
23 the air. 51, very intelligent, very good. Couple of
24 months ago crashed into the ground, died.

25 It was really heartbroken for me and my wife to

1 go and be in Rand Airport in the ceremony for his memory.
2 What I'm saying is that we have a plane and we have two
3 pilots. One is finishing his course now or maybe has
4 finished just now. The other one is a microlight pilot.
5 That is our pilots. I really don't want to be involved in
6 something happening to them and their airport as part of
7 Ingwelala. I don't think that they are qualified. I think
8 they are amateurs. I think we are biting something that is
9 not for us to be involved with.

10 CHAIRPERSON: Thank you. Please go
11 ahead.

12 MS MATTHEWS: Lynn Matthews, unit 164.
13 Mr Chairman, I just want to look at the wording of
14 resolution number 3. The members accept with grateful
15 thanks the donation made. I do believe that it would be
16 very dangerous for our members to accept this donation
17 because we then have undertaken to receive it and surely
18 when it gets distributed to the next company we have got to
19 in turn pay whatever tax on it. It's got to go through the
20 books in other words and I believe it should not go through
21 the books at all.

22 CHAIRPERSON: Thank you. So I would like
23 to sooner rather than later put it to the vote. Are there
24 other comments?

25 MS MATTHEWS: Mr Chairman.

1 CHAIRPERSON: Sorry, Madam. I thought
2 you were over. My apologies.

3 MS MATTHEWS: Sorry, but a lot of the
4 discussion, the recent discussion has gone around the
5 following resolution with regards to the plane.

6 CHAIRPERSON: Usage of the plane.

7 MS MATTHEWS: May I make a comment about
8 that?

9 CHAIRPERSON: Please.

10 MS MATTHEWS: We received as members a
11 60 057 page document recommending the purchase of the
12 Skywalk plane which in any event had already taken place.
13 That document to me reads like a sales pitch rather than a
14 balanced assessment of the situation. With respect I
15 believe the board exceeded its mandate, then attempted to
16 correct this by changing the MOIs. For me personally this
17 felt sneaky and has unfortunately led to a loss of trust.

18 It is important that board and staff members who
19 are currently devoting much of their time and energies to
20 other things now are refocussed on their responsibilities
21 to the share block owners. I have a few examples. The
22 ineffective malaria sprays, we have never had malaria at
23 Ingwelala in all the years we have been members.
24 Inefficiency in the workshop, inefficiency of the
25 maintenance teams, we personally have been charged for a

1 broken window that was said to be a baboon break in but the
2 window was broken from inside while we were not there.

3 The operation and proper management of the shop,
4 the shop currently specialises in the sale of liquor but
5 try and buy a candle or a mantle for your gas lamp and you
6 can't get it. Security and application of the Ingwelala
7 book rules to all resident in the staff village. Parties,
8 shouting, loud music all audible from the main road, it is
9 extensive and it is often. Unrecorded visitors to the
10 staff village, we do not know who these people are.

11 Blatant disregard of bush rules by members holding private
12 fundraising events on our farm. Thank you, Mr Chairman.

13 CHAIRPERSON: Thank you, Madam. It is
14 arguable that some of those are personal perceptions but we
15 understand your background in that regard. Thank you for
16 your comments. We have one in front of you. Is that all
17 right? Ja, go ahead please.

18 CHRISTINE: Okay, I'm Christine from 206.
19 Just sweet and simple and that is the footprint of
20 Ingwelala versus the footprint of Umbabat versus the
21 Kruger, we are a postage stamp. Do we really need an
22 aeroplane or have we just lost perspective? That's just my
23 question.

24 MALE SPEAKER: Mr Chairman, (inaudible)
25 from 111. I don't fight battles on paper and in boardrooms

1 and that. I am a volunteer anti-poaching member in the
2 Pilanesberg and I am a medical officer on top of that so
3 it's volunteer completely and I do this every second
4 weekend. An aircraft is a game-changer. We at Pilanesberg
5 are flying a Bat Hawk which we've been doing for the last
6 couple of months, the last six or seven months or so. And
7 that aerial view is three-dimensional, much more three-
8 dimensional than a ground patrol. I do foot patrols. I do
9 fence patrols.

10 I save - we go in and save calves and things. An
11 aeroplane gives you that extra time. If you do have an
12 incident where a cow is killed and you need to save that
13 calf on a foot patrol you will not get it. You are losing
14 two animals at the same time. So I can just say obviously
15 the aeroplane will not just be used for anti-poaching but
16 for conservation areas. It is for erosion control. It is
17 for alien vegetation control.

18 These are all the things that the board has said
19 that the aeroplane could be used for so it's not just for
20 anti-poaching so the fact that the danger of being shot and
21 that is in our area there I believe a minor risk compared
22 to the benefits that we'll get from that aircraft. So I
23 just want to say to you from someone who's active in the
24 field and I do get my boots dirty an aircraft is an
25 absolute game-changer to conservation and it is a massive,

1 massive deterrent. The guy will not fire a shot if he
2 hears an aeroplane coming around. That's absolutely the
3 necessity of an aeroplane. So thank you.

4 CHAIRPERSON: Thank you. Are there any
5 new speakers? Thank you.

6 MR EBENING: Walter Ebening, 106. I've
7 listened to all the views this evening and, Jannie, very
8 interesting to hear your view. So I had a game farm or
9 part of a game farm in the settlers area before I bought a
10 share in Ingwelala. And our neighbour had rhino on the
11 game farm and people came in, a gang came in with AK47s and
12 they shot, killed three of the rhino and wounded two
13 others. And the farmers then offered us on our farm the
14 remaining rhino.

15 Now, I don't know about you but I don't like the
16 idea of people with AK47s running around on property where
17 I want to enjoy myself and relax and that's the risk. This
18 is the risk that we actually are faced with. And I just
19 can't understand how we get so involved and so upset about
20 the fact that a plane has been bought for R450 000.
21 People, R450 000 doesn't even buy half a diesel land
22 cruiser, not even half of that. The cost of this plane and
23 you might say that the running costs should be covered and
24 not etcetera, it's infinitesimal. It is tiny compared to
25 the costs of running the reserve. It absolutely is. The

1 reserve runs on a budget of -

2 CHAIRPERSON: R10 million. R10 million.

3 MR EBENING: R10 million. That's what we
4 use. That's what we spend in a year. And we're getting so
5 upset about a R450 000 plane that wasn't paid for. None of
6 you have been asked to pay for the plane. And as the board
7 has then tried to accommodate members who've said you can't
8 do this, you can't do this, they have tried to accommodate
9 everybody else. But people, we're talking about the
10 murder, the killing of rhino. This is not something that
11 we're discussing that possibly might happen in the future.
12 Okay, but then why are we not willing to spend -

13 CHAIRPERSON: Right, so thank you -

14 MR EBENING: So why are we not willing to
15 spend some effort in a means to prevent this? And it's a
16 small means, people, and it's a small cost.

17 CHAIRPERSON: Thank you, Walter. Are
18 there any new speakers? Before you start, Mr Vos, I have
19 had a suggestion that we put this to the vote at this
20 stage. Are we in agreement? Is there anybody -

21 MALE SPEAKER: There is a new speaker, Mr
22 Chair.

23 CHAIRPERSON: Is there not, is there
24 anybody who's not in agreement to put this to the vote?

25 You want, Madam, something to say. Mr Vos, your last turn,

1 Mr Vos, please.

2 FEMALE SPEAKER: (inaudible).

3 CHAIRPERSON: Sorry, Madam, could you use
4 the microphone and tell us who you are?

5 FEMALE SPEAKER: Sorry, also 111 here. I
6 just want clarity. The other gentleman earlier on said
7 this is trust versus Ingwelala, aeroplane equals trust, not
8 Ingwelala.

9 CHAIRPERSON: Yes.

10 FEMALE SPEAKER: Is that what we are
11 voting on now?

12 CHAIRPERSON: Yes, amongst - so we have a
13 speaker and out of courtesy let's listen to Lynn.

14 MS MATTHEWS: Thank you, Mr Chairman. I
15 just want to talk about poaching. Rhino poaching and other
16 illicit activities are certainly a concern for all
17 Ingwelala shareholders and members but there are dozens of
18 separate groups and organisations in the area all setting
19 up different arrangements often independently and often
20 duplicating what the other is doing. The area is vast.
21 Ingwelala is a drop in the ocean in comparison. We do not
22 own or control rhino, i.e. if the rhino move to another
23 space they may still be killed. We have the advantage of
24 the roads being regularly traversed by members which should
25 and up to now has deterred poachers. The problem is

1 massive. We must all work together and apply our minds
2 rather than our emotions to real, practical, meaningful
3 solutions.

4 CHAIRPERSON: Thank you, Lynn. All
5 right. I am now putting resolution 3 and 4 since a lot of
6 the debate has been about number 4 as well as about number
7 3 as the - we've had a - I better take care of the
8 formalities. Proposer for resolution number 4. Be with
9 you in a moment.

10 MR DE VOS: No, no, first of all let's
11 finish with resolution 3. I made a counterproposal that
12 resolution 3 be withdrawn so there must first be voted on
13 my counterproposal.

14 CHAIRPERSON: So okay, thank you, Mr Vos,
15 for reminding me. So the resolution number 3 we're putting
16 to the vote. You have the papers in front of you. Please
17 indicate in due course. Your vote will be collected after
18 resolution number 4. I'm moving to - after number - sorry,
19 what have I done?

20 MR DE VOS: There was a counterproposal,
21 Mr Chair.

22 CHAIRPERSON: All right. The proposal is
23 that number, resolution number 3 be withdrawn. All those
24 in favour. All those that seek to vote on resolution
25 number 3. I'm not able to determine accurately in that

1 regard. I would then ask the permission of, given the
2 uncertainty ask the permission of the meeting to proceed to
3 voting on number 3 because that would be decisive. So if
4 you don't like it could you vote against it? If you do
5 like it vote in favour of it. Thank you very much. I've
6 made a ruling. Resolution number 3, please vote.

7 I'm now moving to resolution number 4. So
8 resolution number 4 reads, originally it said to support.
9 It says now authorise the boards of directors of the
10 Ingwelala companies in their endeavours to acquire access
11 to and usage of the light aircraft, Savanna Light Sport
12 Aircraft, for conservation and anti-poaching efforts as
13 more fully described in the proposal document. This
14 authorisation is sought on condition that the acquired
15 aircraft is not owned by any Ingwelala entity and is owned
16 independently for example by the trust as envisaged in
17 resolution number 2 and is used for service in anti-
18 poaching efforts at the properties owned by Ingwelala
19 entities, Nkorho, Umbabat, APNR, SANparks and similar
20 entities on a best endeavour basis for the recoupment of
21 the aircraft owner, by the aircraft owner of capital and
22 operational costs. I have a proposer. Do I have a
23 proposer? Andrew. Do I have a seconder? Nick Rit.
24 Andrew, do you wish to speak to the resolution please?

25 MR ROSSAK: Mr Chairman, can you all hear

1 me? I'll try and be brief. It's a very emotive topic.
2 I'm Andrew Rossak. I'm bungalow number 47. I've been a
3 director probably with Christa and Andrew Wessel almost
4 since then. We have a free asset here. It's held
5 independently of Ingwelala. We have a free option to use
6 this tool for our conservation and for the benefit of the
7 members, not necessarily just at Ingwelala but the benefits
8 of Ingwelala are - we rely on the good upkeep and the
9 management of the Umbabat and the entire conservation area.

10 So we can't be narrow-minded. Conservation is
11 not an island activity. If this tool works and we have
12 good reason to believe that it will in managing our
13 protected wildlife it will be fantastic. And if it does
14 work we can use it as much as we want or as much as we can
15 afford. If for some reason the envisaged tool doesn't make
16 the difference that we expect it to we can sell it. It's
17 no big issue. Costs are reasonable and well within our
18 control. And unlike a horse we only need to feed it when
19 it flies.

20 The risk has been carefully considered. We have
21 had a great deal of consultation with aircraft users doing
22 exactly this in the area and we believe that the board has
23 looked carefully into this. We believe that the risks are
24 mitigatable. There are standard operating procedures and
25 systems in place, developed through many years of bush

1 flying and we believe these, may we maintain these we will
2 maintain the risk management.

3 The aircraft will be used as a well-structured,
4 through a well-structured and cooperative and coordinated
5 security system and contrary to the earlier speaker in fact
6 in the entire APNR and Sabie Sands the western boundary and
7 you've seen the proposal, the comments the GQF works
8 extremely well. It is not an uncoordinated body. We're
9 actually extremely well-coordinated. Since August last
10 year and in fact a year now we have had amazing success and
11 good coordination through the security which is combined
12 with Kruger.

13 This coordinated grouping has given not only our
14 support but our request to station an aircraft in the
15 Ingwelala area because this is where there's a significant
16 vulnerability and there is a difficult - there is no
17 aircraft that can easily cover that area at the moment.
18 The aircraft is a well-established proven tool in
19 conservation worldwide and especially in Sub-Saharan
20 Africa. There are many places where great success have
21 come from using these aircraft. We have a suite of threats
22 right on our doorstep, biodiversity and others, and this
23 tool will be a great asset to addressing these. The
24 proposal circulated contains a lot of detail and I won't go
25 into that but here we have a great opportunity.

1 We have a free asset in a separate company. We
2 have a board and staff support. We have volunteer pilots.
3 We have good member support and we have sound operating
4 procedures to manage this asset. There are very few other
5 places or reserves that could do this. Our security issues
6 at Ingwelala are different to other places. We don't have
7 hard boundaries. We need to think a little bit differently
8 about how we operate our security and I urge you all to
9 seriously consider this and to vote clearly on this and a
10 positive vote because I think it will be a beneficial
11 asset.

12 MR DE VOS: Christo de Vos, 87 again.
13 You see, Mr Chairman, my big problem with this is I hear
14 Andrew saying it's free. Now I read the resolution. The
15 resolution says for the recoupment by the aircraft owner of
16 capital and operational costs. Now what is true? Is it
17 free or is it for the recoupment of capital?

18 CHAIRPERSON: The purchase of the
19 aircraft was free because it came out of donations. The
20 operational costs will have to be borne by the trust and
21 operational costs would have to be recouped as best as
22 possible, not necessarily from Ingwelala.

23 MR DE VOS: But then you must change the
24 resolutions because this resolution, this is not what the
25 resolutions say that you want us to vote on. And that is

1 the problem with the whole thing. You see, if this
2 aircraft is really out of our domain, if it's not our
3 aircraft, if it belongs to a trust why must we now vote on
4 it? Why can't the trustees at the time in question
5 approach us or approach Umbabat with a proposal to say that
6 we must hire the plane? And then because if you vote on
7 this resolution -

8 CHAIRPERSON: Mr Vos, sorry.

9 MR DE VOS: No, let me finish.

10 CHAIRPERSON: Mr Vos.

11 MR DE VOS: No, sorry, sorry.

12 CHAIRPERSON: Sorry to cut you short.

13 I'd like to explain that the resolution is not as you are
14 suggesting. The resolution is to authorise Ingwelala to
15 talk to that trust that you're talking about in order to
16 acquire access to the aeroplane. So this is an intention
17 for the members to say, yes, let us use that trust's
18 aeroplane.

19 MR DE VOS: But at what cost? You see,
20 then we authorise you. We give you an open chequebook to
21 say go there, pay these guys a million rand a year.

22 CHAIRPERSON: No, come on.

23 MR DE VOS: I mean, this is what it
24 reads.

25 CHAIRPERSON: No, come on.

1 MR DE VOS: It says it. Or R100 000.

2 CHAIRPERSON: We don't have a million
3 rand to pay anyone, Mr Vos, so please.

4 MR DE VOS: Well, I don't know.

5 CHAIRPERSON: Ingwelala does not like to
6 provide, to obtain and buy services from anybody without
7 paying a fair fee for it so please don't suggest that we're
8 going to pay a million rand for anything.

9 MR DE VOS: No, well, 100 000. May I
10 suggest that then? Because why don't you then change your
11 resolution to say that this thing will be out of Ingwelala
12 and they will approach the necessary authorities be it
13 Umbabat or be it Nkorho to make a deal but it must be fair
14 and competitive to other similar aircrafts in the region.
15 Thank you, Mr Chair.

16 CHAIRPERSON: Thank you.

17 MR BEZUIDENHOUT: Mr Chairman, sorry,
18 it's Jannie Bezuidenhout again from number 60. I hear what
19 the gentleman was saying about the small cost. For me it
20 goes about the fact that Ingwelala staff is flying for
21 another company which means if that aeroplane comes down at
22 the end of the day we are liable because they work for us,
23 not the other company, because they fly voluntarily. So
24 it's not part of their job description per se so if the
25 aeroplane, and that is in short I think by my arguments are

1 there, everything.

2 CHAIRPERSON: Thank you.

3 MR BEZUIDENHOUT: But in short my
4 suggestion is if you want the aeroplane in a different
5 company let the staff members who want to fly it resign and
6 go and work for that company. Then they are liable for
7 that and then the insurance covers will be part of that.
8 And then we can - or if we need the aeroplane we rent the
9 aeroplane from that company. Keep the aeroplane -

10 CHAIRPERSON: That's not the resolution,
11 Mr Bezuidenhout. That's what the resolution's about is if
12 we need it we ask for it and pay for it.

13 MR VAN STADEN: Marius van Staden, 173.
14 There's some misconception. If the employees of Ingwelala
15 as part of their duties fly the aeroplane it will be
16 workmen's compensation claim. Ingwelala won't itself have
17 to pay the claim.

18 CHAIRPERSON: Thank you.

19 CHRISTINE: Okay, Christine from 206
20 again. Just one thing, I go to Ingwelala because it's
21 quiet. I want to see the game and I want to enjoy the
22 peace. I'm not sure I want an aeroplane flying overboard
23 while I'm watching a lion kill. How do we have control of
24 what's happening when? And I know that when there is legal
25 culling of elephants they leave when these aeroplanes are

1 flying and looking. Do we really want to chase our game
2 away as well?

3 CHAIRPERSON: So I'm now going to ask you
4 to vote on the resolution on your ballot paper. We have a
5 final question if I may please, Sir.

6 MALE SPEAKER: (inaudible) from unit
7 number 25. Mr Chairman, I've listened to a lot of people
8 talking tonight and a lot of Mr De Vos and various people
9 that are saying the same stuff. I come, I was born and
10 brought up in Zimbabwe and I worked in Zimbabwe game
11 reserves with rhino and those are now gone. This is a
12 reality. It's going to happen in your lifetime that we
13 will not have rhino anymore and it's not only the rhino.
14 It's elephant and other game as well.

15 If Ingwelala do not do something about it
16 nothing's going to change. We're tried. We've done
17 nothing for ten years, 20 years. This is a problem that's
18 happening now and it's not going to go away. If we carry
19 on doing what we're doing which is basically what we've
20 been doing for the last ten years the rhino will be gone.
21 It's not about our little poster stamp in the Kruger Park.
22 We have in this room and with all the members a significant
23 pool of money that can do something in that area and it's
24 not about saving the rhino in Ingwelala property.

25 I can't even remember when I last saw a rhino on

1 Ingwelala property. They come and go because the fences
2 are down and they are territorial so they generally stay in
3 the area that they're in. It's about us being able to do
4 something for the entire area because we have that pool.
5 We can't expect the individual farm owners to do anything.
6 They haven't got the money. They haven't got the
7 resources. They haven't got the capital. If we don't do
8 something the rhino will be gone and in ten years we're all
9 going to sit here and say I wish we had just done
10 something. This is doing something.

11 CHAIRPERSON: Thank you, Sir. You agree
12 it's the last one.

13 MR RICHARDS: 194, John Richards. Just
14 to say I agree with the fact that we need to try and save
15 the rhino but it's not up to Ingwelala to do that. What
16 about the whole of Umbabat and (inaudible) and everybody
17 else? Ja, not just us.

18 CHAIRPERSON: So Umbabat as well. Okay.
19 So now we move to voting and I'd like to appoint some
20 scrutineers. I appoint the company secretary, Charl du
21 Plessis. I appoint the financial person, Gavin Maile, and
22 I appoint Mr Trevor Bunt to go and count the votes together
23 with the financial accountant, Natalie. She's got a little
24 model on her computer. Natalie will come around or
25 somebody will come around. Someone will come around and

1 you can place your ballot papers in the box for that.

2 Until the scrutineers come back I'm adjourning the meeting

3 but please don't go away so that we can hear the outcome.

4 Thank you for the indulgence.

5 [MEETING ADJOURNS MEETING RESUMES]

6 CHAIRPERSON: So welcome back, everybody.

7 Thank you to the scrutineers who've done the work. So I've

8 been handed this list. I'm going to go through Ingwelala

9 1500 shares of which 1043 were present. For resolution

10 number 1, 970 voted in favour. It's overwhelming majority

11 and therefore the motion is carried. For resolution number

12 3 for Ingwelala so it needs 1 043 votes, 528 voted in

13 favour which is more than the 522 which is half so the

14 resolution is carried in Ingwelala. In resolution 4 the

15 pass mark is 522 for 50% so resolution 4 in Ingwelala the

16 yes votes were 537 so resolution 4 is carried in Ingwelala.

17 For Buffelsbed resolution number 1 is 135 votes.

18 Half mark in Buffelsbed would be in a majority 72%. So

19 resolution 1 in Buffelsbed is carried. Resolution 3 in

20 Buffelsbed the pass mark is 72. Resolution 3 got a 71 and

21 a half vote so it is not a majority so it's not carried.

22 Resolution 4 in Buffelsbed the half mark is 72 and the yes

23 votes were 73 and a half so it's carried, resolution 4, in

24 Buffelsbed.

25 In OP Goedehoop the pass mark is 72 and in

1 resolution 1 it was 130 yes votes. Resolution 1 in OP
2 Goedehoop is carried. Resolution 3 the yes votes were 70
3 and a half which fails the 72 pass mark. In resolution 4
4 the yes votes were 73 and a half which passes the pass mark
5 of 72. In Sibon 121 yes votes of the 138 so overwhelming
6 majority. Resolution 1 passes. In resolution 3 the pass
7 mark is 70 for resolution 3 in Sibon and the yes votes were
8 69 and a half so the resolution is not carried. Resolution
9 3 is not carried for Sibon. And resolution 4 for Sibon the
10 pass mark is 70 for 50% and the yes votes were 71 and a
11 half and so resolution 4 is carried.

12 In summary resolution 1 is carried in all four
13 companies. Resolution 3 is carried in Ingwelala but fails
14 in the others. And in resolution 4 the resolution 4 in all
15 companies is carried. I have the signature of all the
16 various people that did the counting. I move to agenda
17 item number 5 which is any other business on the agenda
18 that we are prepared to discuss other than that which we
19 have. Are there any questions and answers? Yes, Sir.

20 GAEM: (inaudible).

21 CHAIRPERSON: Sorry, I beg your pardon.
22 Can I ask you because it's a recorded meeting.

23 GAEM: I think that with regards to -
24 sorry, Gaem from unit 18. I think the split in Ingwelala
25 is evidence of here where we have roughly 50% and 50% apart

1 from resolution number 1. When it goes to resolution in 3
2 and 4 we in Ingwelala are split. The difference is
3 between, I don't know, very small.

4 CHAIRPERSON: Very small.

5 GAEM: And I think that you need to take
6 a second thought about it because it's splitting Ingwelala.
7 It's creating a lot of bad feeling to some of the people.
8 I think that this is a new thing that have to come that
9 does not represent the majority of Ingwelala. It represent
10 maybe 50 or 51% or 52. I think it will be wise to make
11 sure that this decision is delayed or this decision is not
12 taking place now or this decision is being brought to
13 another voting in the future but not to split Ingwelala on
14 such a short and small majority that does not represent
15 most of us. We must also take into consideration that
16 there's a lot of people that are not present and they have
17 also an idea about it although they didn't bother to come.
18 I think that this is a decision that cannot be taken
19 forward and I'm talking about 2 and 3, 3 and 4 without -

20 CHAIRPERSON: Further consideration.

21 GAEM: Further consideration.

22 CHAIRPERSON: Thank you very much. Your
23 sentiments have been, your sentiments reflect some of the
24 preliminary thinking that the board has considered. It is
25 also fair to respect the wishes of the majority however

1 slim it is but on the other hand your comments are also
2 valid so thank you very much for those comments.

3 MR VAN STADEN: Marius van Staden, 173.

4 I think, this is a personal perspective so it may not be
5 correct, but part of the problem of this whole debacle of
6 the aeroplane arising I think is because of a lack of
7 communication between management and the members and with
8 the previous setup, you know, you could walk down the path
9 towards the shop and you could see the general manager and
10 every now and then you would pop in, you would speak to the
11 general manager and you would relate some of your thoughts,
12 some of your input, some of your concerns and you knew that
13 there was fertile ground.

14 The general manager was receptive to listen to
15 you and to interact with you. But I get the distinct
16 feeling that the new complex was designed to keep the
17 general manager away from the members. If you get to the
18 reception area there's a big sign that says private. Don't
19 enter. So speaking for myself I'd like an hour a day to be
20 set aside by the general manager to interact with the
21 members so that the members' concerns can be raised with
22 the general manager and so that there can be more sort of -
23 the employees know what the members want and what they
24 don't want. Thank you.

25 CHAIRPERSON: Thank you. Thank you for

1 your perspective. Mr Vos.

2 MR DE VOS: Thank you, Mr Chairman. One
3 of the big problems that I have and I've encountered this
4 now because I've been involved in this whole aircraft
5 debacle now for more than a year is how do I communicate
6 with the members of Ingwelala. I sent my letters through
7 to the board and I asked that to be distributed but it's
8 not being done. And so other members who also had concerns
9 sent letters in and asked it to be distributed like Mr
10 Watson and it was never done.

11 So is there a way that we can have a platform and
12 I'm talking to the members where we can contact each other?
13 I would like to know why a guy think a certain way. Why is
14 it kept away from us? Why it's a story of divide of rule?
15 You know, we must feed all of the information to the board
16 or management. They decide how they're going to distribute
17 it. They decide the trend of the letter that's going to go
18 out. So for me, and I don't know how the other members
19 feel about it, but I would like to be able to communicate
20 to all the members and I'm sure I would want to hear about
21 all the members, what they feel about something. And I
22 don't know how we're going to address this.

23 CHAIRPERSON: Thank you, Mr Vos. So
24 there was a comprehensive proposal document that was sent
25 to all members and it was built to answer the questions.

1 There were further questions. There was a further round of
2 questions and answers. There have been quite a number of
3 communications during the year. I don't know the easy
4 answer on how to relay one person's views to the others.
5 We are talking about a new communication strategy. But it
6 is difficult. There is a space on the website for a
7 grievance corner and for communications. And it doesn't
8 always work. In the five years or six years it's been
9 there I don't see anyone has done it at all. So I don't
10 really know how a member's letter could be distributed to
11 everyone but thank you for your comment. We will debate it
12 internally on the board. Madam.

13 FEMALE SPEAKER: Mr De Vos, I just need
14 to make you aware of the fact that we have a database of
15 everybody, of all the members. That database is
16 sacrosanct. It may not be used for any other purposes in
17 terms of POPI. Thank you. POPI.

18 CHAIRPERSON: The Act.

19 FEMALE SPEAKER: POPI is coming in and we
20 have to be very careful what we allow out to whom. So if I
21 don't like the board I do not have a right to ask the board
22 for every single member's e-mail address and you need to
23 take that into consideration. Thank you.

24 CHAIRPERSON: Thank you. So I would like
25 to suggest that given the narrowness of the vote, given the

1 strength of the debate, given the strength of demonstrated
2 feelings that we make a special effort to try and heal some
3 of this division into the future in whichever way. The
4 board is going to consider the narrowness of the voting
5 whichever way it was and as Hein has indicated, you know,
6 think about how this can be improved upon in some fashion
7 without disrespecting the votes of all the members. So
8 unless there's a topic on some other issue - hello, Gavin.

9 MR MAILE: Gavin Maile, number 4. I have
10 been a member at Ingwelala for about 21 years, maybe going
11 on 22. And most of those years have been really, really
12 happy years in these meetings. There was a period 15 years
13 ago when there was a lot of emotion that was spread at
14 these meetings but what I have found very uncomfortable as
15 a new board member - now there were six new board members
16 voted in by you guys November last year. That means there
17 were only six people involved beforehand.

18 But the accusations by many members to the board
19 assume that the new board members are not prepared to stand
20 up for their own rights. Now we were voted by you and it
21 was the, one of the very few times in 21 years that I know
22 where there were more people standing for positions than
23 positions available. I would hate to know what's going to
24 happen in November next year. I've seen how much work is
25 involved in the portfolios I'm involved in but then with

1 all these other things and somebody said let's get
2 together, let's talk the same language and let's focus on
3 what's important.

4 Because the board has spent an enormous amount of
5 time on these other things and they are important because
6 some members are upset. But I think everybody's entitled
7 to their own view and to ask their own questions. But from
8 my side this has not been an easy experience. It's nothing
9 that I ever envisaged the amount of time that's been
10 involved in here and we do it because we love Ingwelala.
11 Our investment in Ingwelala is worthless if we don't have
12 big five game. And if you look at what's happened to the
13 values of properties and over the period of time they've
14 escalated.

15 I heard of a unit today for sale for 6 million.
16 I suspect that person paid about R50 000 for that unit and
17 it's on the market shortly for R6 million. Now that's not
18 because we are a un-unified bunch. We generally are a very
19 unified bunch. And it's something we need to continue to
20 aspire. But if we lose our rhino, if we lose our other
21 things, we might as well throw our investment away. Nobody
22 is going to buy that. But we all believe in it. We all
23 want that place and we all love the place.

24 So I'm prepared to sacrifice my own time to put
25 something back after 20 years of other people being on the

1 board and to give. And I'm not going to do anything that
2 destroys my own investment because that's something I live
3 for and it's an investment I'm never going to dispose of.
4 But things if they change is something that might not be
5 worth anything. So I think it's useful for everybody to be
6 part of this happy place and to be positive about finding
7 solutions.

8 So let's not look for problems, for Is that
9 aren't dotted or Ts that aren't crossed. Let's look at
10 possible solutions and let's try and work together. The
11 board to me is not them and us. You elected us. You put
12 your faith in us. You expect us to deliver on what you
13 appointed us to do. So we also need to be allowed to do
14 what we believe is right. And every year there's a new
15 number of people that come in so if you don't like people
16 they can be voted off quite easily at that point, or not
17 off but they don't get re-elected. So thank you.

18 CHAIRPERSON: Right, thank you. So I'm
19 looking for closure, Mr Cochran.

20 MR COCHRAN: Look, there's a number of
21 us, you know, present here who have served on the board and
22 what not and done all sorts of things. And I don't think
23 it's as very much appeal to sentiment, okay. This aircraft
24 thing has caused a big division amongst the people here and
25 it's the same as, you know, somebody else was saying about

1 rhinos. Obviously nobody here would argue with trying to
2 do what is ever necessary to stop rhino poaching. So you
3 know, the people that are against that you must understand
4 that they don't think it's going to work and it's no finger
5 pointed at the board. The board has got a particular view
6 on it.

7 There's no, and there's nobody here and I've
8 never read anything who's going to say that an aircraft is
9 going to be the solution to the whole problem. So please
10 don't believe that the board is being under - so many
11 people on the board that I've served with that I've got a
12 huge regard for. I love them. Okay. So please don't
13 appeal to sentiment. That's all I'm saying to the people
14 here. All right. We want or Ingwelala, we all love it.
15 That's why all these people are sitting here. But please
16 don't think that because somebody is against having an
17 aircraft at Ingwelala is pointing a finger at the board.
18 Thank you.

19 CHAIRPERSON: I hereby declare the
20 meeting closed and thank you for your attendance.
